NOTICE OF ADOPTION
With respect to Official Plan Amendment No. 27
Section 17 and 26 of the *Planning Act*, R.S.O. 1990, c.P.13

On February 23, 2017, the Council of The Regional Municipality of Peel passed By-Law No.12-2017 to adopt Amendment 27 to the Region of Peel Official Plan (“ROPA 27”).

Purpose and Effect

The purpose and effect of ROPA 27 is to introduce new policies to the Regional Official Plan to support and encourage the creation of a healthy built environment and communities that better meet the needs of an aging population. The amendment also implements several technical and administrative updates to the Regional Official Plan.

Written and Oral Submissions

Stakeholder comments were received and considered throughout the Regional Official Plan Amendment process. Written and oral submissions made by stakeholders were considered by Regional Council and have led to a number of revisions in the adopted ROPA.
