If a person or public body does not make oral submissions at a public meeting or make written submissions to the Regional Municipality of Peel before the proposed official plan amendment is adopted, the person or public body is not entitled to appeal the decision of the Minister of Municipal Affairs and Housing to the Ontario Municipal Board. Also, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to add the person or public body as a party.
