

# **B3 Fund Tip sheet: Application assessment**

# **Community Investment Program**

The Community Investment Program is committed to assessing funding applications in a transparent way. This Application Assessment Tip Sheet provides clear information about how applications for the 2024 B3 (Black-led, Black-focused, and Black-serving) Fund will be assessed. Applicants are encouraged to refer to this tip sheet as you complete your application.

### Who reviews my application?

Each application that meets the fund's general eligibility requirements is reviewed by 2 members of our Fund Review Committee.

More about the committee:

- This committee may include Peel Region staff, other funders from foundations and the municipalities, as well as community members with lived experience.
- Community representation has been added to the Fund Review Committee as a new measure to ensure there is community voice in the B3 Fund decision-making process.

### How will my application be assessed: General

#### **Demonstrated Need**

Applications will be evaluated based on how well organizations use an evidence-based approach to demonstrate how their budget request will improve their organizational capacity and positively impact Black communities in Peel.

### Principles of Interconnectedness, Human Rights & Social Justice

Application questions have been designed to provide an opportunity to show the impact of an organization's programs and services within Black communities. The 2024 B3 Fund has adopted the Ubuntu Principles in both the application and the funding approach (i.e., Fund Review Committee make up and B3 Application Form). This includes how an organization recognizes the interconnectedness of individuals within a community and how their impact on individual program participants impacts the wider community. Applicants will also be required to demonstrate how their organization supports human rights and social justice - specifically how their work positively impacts the wider Black community / communities.

### Alignment to Sector and Priority Populations

B3 organizations are the experts in identifying priority populations and emerging issues that affect Black communities in Peel. The sector and priority population lists in the application have been shaped by input from our B3 Advisory Board and survey data from Peel B3 not-for-profits in April 2024. If your sector or priority population is not listed, include it in the "Other" category. Applicants must clearly demonstrate how their program and services support the sector and priority population selected in their application form.

# Financial Assessment (/100%)

Applicants must demonstrate good financial health. A financial assessment is included in the application review process to broadly assess risk present in not-for-profit funding applicants.

Financial assessment is an important step to check the financial health of an organization applying for funding. It helps gauge an organization's ability to carry out the proposed work and meet the requirements of the fund, and it helps assess the risk to determine if an organization may not be able to do so. In finance and in funding, this is commonly referred to risk assessment.

This assessment is done by Peel Region's Finance team. The Finance team analyzes each applicant's submitted financial statements for risk factors by analyzing financial ratios.

There are 5 categories for the financial ratios:

- 1. Liquidity: The organization's ability to meet short-term financial obligations
- 2. Leverage: The organization's ability to operate within their means during the year; assets that are financed by creditors; liabilities and debt.
- 3. Profitability: The average of the last two years of Surplus (Deficit)
- 4. Revenue: Diversity of revenue sources
- 5. Expenditures: Looking for a high proportion dedicated to delivering programs

Applicants are given a score out of 100%. A financial score threshold will be set by the CIP team. All applicants who meet this threshold will move to the next step of the review process to be considered for funding.
