THE REGIONAL MUNICIPALITY OF PEEL

BY-LAW NUMBER 38-2018

A by-law concerning the expropriation of land, being Part of Lot 1, Concession 4, Town of Caledon (formerly Township of Albion), Regional Municipality of Peel, as in Instrument Number RO902724 being All of PIN 14349-0027 (LT).

WHEREAS, The Regional Municipality of Peel (the "Regional Corporation") needs to acquire the lands described in Schedule "A" hereto for the purposes of the widening of Mayfield Road from Airport Road to Coleraine Drive and the construction of a 600mm watermain within the Mayfield Road right of way and all works ancillary thereto;

AND WHEREAS, Section 6 of the *Municipal Act*, 2001, S.O. 2001, c.25 as amended ("*Municipal Act*, 2001") confers on the Regional Corporation the power to expropriate land;

AND WHEREAS, Section 11 of the *Municipal Act, 2001* confers on the Regional Corporation jurisdiction in respect of highways and public utilities;

AND WHEREAS, the Council of the Regional Corporation has by resolution passed on June 28, 2018 authorized the commencement of procedures to expropriate land;

NOW THEREFORE, the Council of the Regional Corporation enacts as follows:

- That Application for Approval to Expropriate Land in the form attached hereto as Schedule "A" under section 4 of the Expropriations Act, R.S.O. 1990, c. E.26, as amended, be made to the Council of the Regional Corporation in respect of the parcel of land as described in Schedule "A" to this by-law and that it be executed on behalf of the Regional Corporation by the Regional Clerk and the corporate seal be affixed thereto.
- 2. That a Notice of Application for Approval to Expropriate Land in the form attached hereto as Schedule "B" be executed on behalf of the Regional Corporation by the Regional Clerk and the corporate seal be affixed thereto and that the Notice be served upon each registered owner of the parcel of land to which it relates and be published once a week for three consecutive weeks in a newspaper having general circulation in the Town of Caledon, in accordance with section 6 of the *Expropriations Act*.

- 3. That the purpose of the expropriation of the lands described in Schedule "A" is for the widening of Mayfield Road from Airport Road to Coleraine Drive and the construction of a 600mm watermain within the Mayfield Road right of way and works ancillary thereto.
- 4. That, if there is no inquiry (Hearing of Necessity) held in accordance with the *Expropriations Act*, Section 5 shall be effective on the later of the day after the last date to request an inquiry in accordance with the *Expropriations Act*, or the date on which a withdrawal of a request for an inquiry, if any, is filed. If an inquiry is held in accordance with the *Expropriations Act*, Section 5 shall not take effect.
- 5. If this Section 5 is effective in accordance with Section 4, the expropriation of the land described in Schedule "A" to this by-law is hereby approved and such approval is given on the date this Section 5 is effective, and the following steps are authorized to be taken with respect to the expropriation:
 - i) That the Regional Clerk is hereby authorized and directed to sign and execute on behalf of the Council of the Regional Corporation and affix the corporate seal to a Certificate of Approval, in the form attached hereto as Schedule "C", and to execute all other notices and documents which are necessary to carry out the provisions of this by-law;
 - ii) That a plan of expropriation be prepared and registered in the proper land registry office;
 - iii) That a Notice of Expropriation be served upon the registered owners, together with a Notice of Election form as to the date of the assessment and compensation and a Notice of Possession as to the date the expropriating authority requires possession of the expropriated lands which shall be at least three months after the date of service, all in accordance with the Expropriations Act;
 - iv) That an appraisal report be obtained in respect of the market value of the expropriated lands and, if applicable, damages for injurious affection and other compensation;
 - v) That an offer of full compensation and an offer for immediate payment of 100 per cent of the market value of the expropriated lands as estimated by the expropriating authority be served, together with a copy of the appraisal report, all in accordance with section 25 of the Expropriations Act;
 - vi) That compensation be paid to the owner(s) following the acceptance of the offer made pursuant to section 25 of the *Expropriations Act*;

- vii) That all necessary steps be taken to obtain possession of the expropriated lands.
- 6. The invalidity or unenforceability of any provision of this by-law shall not affect the validity or enforceability of any other provision of this by-law, which shall remain in full force and effect.
