

Peel Health Data Zone M6

Health Profile 2016

The burden of illness and preventable loss of life arises in large part because of the conditions in which people are born, grow, live, work and age.¹ Peel Health Data Zones (PHDZ) arose out of a need for data at small areas of geography to aid with planning programs and services that will in turn work towards improving public health outcomes. The PHDZ are defined geographic areas within Peel that are smaller than the municipality level, use Census Tracts as the building blocks, and where plausible, respect natural and man-made boundaries.

Description:

PHDZ M6 is located in the middle southern area of Mississauga and is a mix residential and industrial/employment areas (see Map 1).

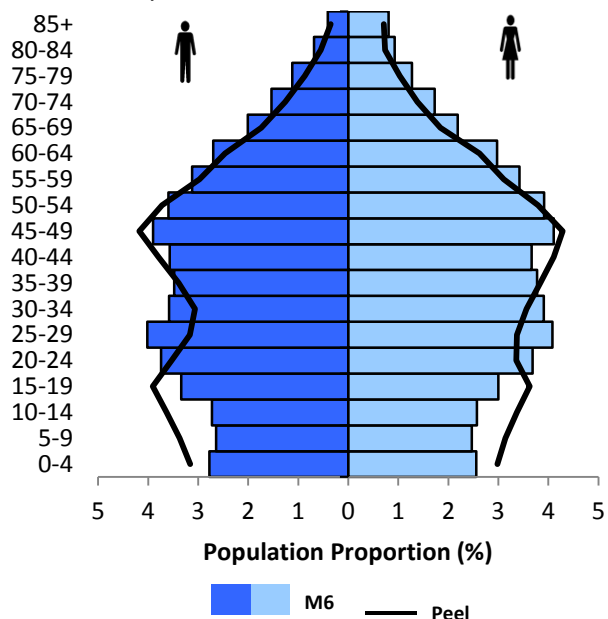
Socio-demographic summary:

A higher proportion of M6's population is aged 25-29 years and 70-79 years compared to Peel. The average household income is \$66,799, about \$12,300 less than Peel's average. M6 has a higher prevalence of low income households (17%) compared to Peel (13%). The top three languages spoken at home are English, Chinese and Arabic. Thirty-four per cent of M6's population identifies as East Indian, Chinese or Canadian.

Adult Health:

Life expectancy at birth in M6 is similar to that in Peel. The leading causes of death among those 20 years and older in M6 are: ischemic heart disease, injuries or poisonings and dementia and Alzheimer's disease. Age standardized mortality rates for M6 compared to Peel were lower for ischemic heart disease and higher for injuries or poisonings. Just under half of M6 residents are classified as overweight or obese (45%) which is similar to Peel (51%). A higher proportion of females age 35+ years in M6 had ever had a mammogram (86%) compared to Peel (60%).

Child health:

A higher proportion of the population aged 0-18 years are living in low income in M6 (24%) compared to Peel (16%). Both the *general fertility rate* and *pre-term live birth rate* are similar to the Peel rates.

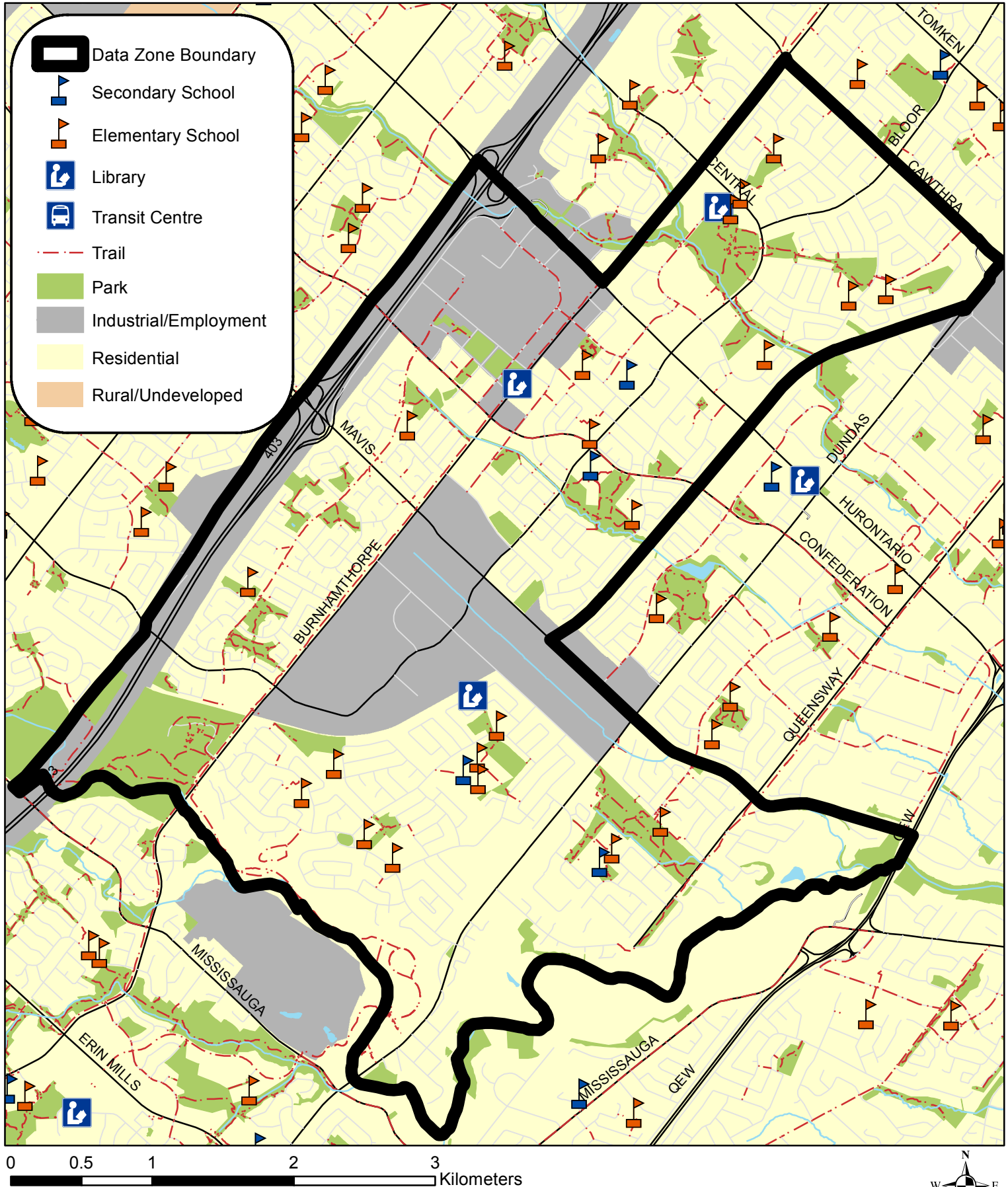
