

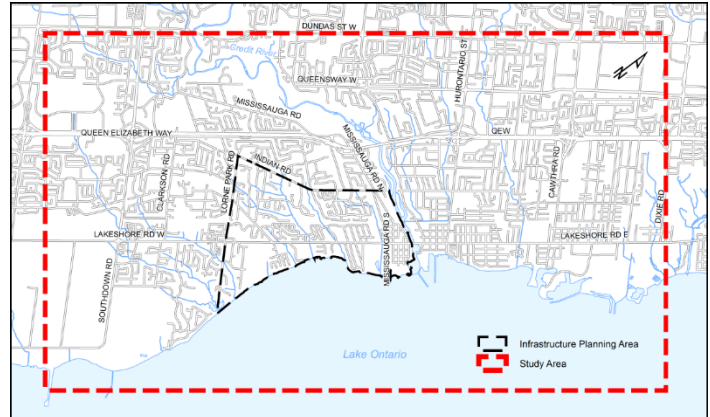
NOTICE OF STUDY COMPLETION

***** REVIEW PERIOD EXTENDED TO JULY 19, 2019 *****
Front Street Pumping Station Wastewater Diversion Project
Schedule B
Class Environmental Assessment

The Study

The Region of Peel has identified the need to address the current Front Street Pumping Station catchment area wastewater flows to align with the Region's long-term sustainable plan to provide wastewater services. The preferred solution includes constructing a new gravity sewer along Lakeshore Road and Pine Ave S, constructing a new wastewater pumping station in Richard's Memorial Park, and decommissioning of the current Front Street Wastewater pumping station located in the Port Credit Lighthouse as well as the decommissioning of the Ben Machree wastewater pumping station.

The above project is being planned under Schedule B of the Municipal Class Environmental Assessment. Subject to comments received as a result of this Notice, and the receipt of necessary approvals, Peel Region intends to proceed with the design and construction of this project.

If concerns arise regarding this project, which cannot be resolved in discussion with Peel Region, a person or party may request that the Minister of the Environment and Climate Change to order a change in the project status and require a higher level of assessment under an Environmental Assessment process (referred to as a Part II Order). Reasons must be provided for the request. Requests must be received by the Minister within 30 calendar days of this Notice.

As of July 1, 2018, a Part II Order Request Form must be used to request a Part II Order. The Part II Order Request Form is available online on the Forms Repository website (<http://www.forms.ssb.gov.on.ca/>) by searching "Part II Order" or "012-2206E" (the form ID number).

If there is no request received by **July 19, 2019**, the Region of Peel will proceed with design and construction of the pumping stations and decommissioning of the old pumping stations, as presented in the planning documentation.

Please note that ALL personal information included in a Part II Order submission – such as name, address, telephone number and property location – is collected, maintained and disclosed by the Ministry of the Environment and Climate Change for the purpose of transparency and consultation. The information is collected under the authority of the Environmental Assessment Act or is collected and maintained for the purpose of creating a record that is available to the general public as described in s.37 of the Freedom of Information and Protection of Privacy Act. Personal information you submit will become part of a public record that is available to the general public unless you request that your personal information remain confidential.
