West Caledon Storage Facility and Transmission Main Schedule 'C' Class Environmental Assessment (EA)

Summary of Public Information Centre No. 1

Throughout this study, public consultation continues to be a key component to success. A Public Information Centre (PIC) serves as a forum for information exchange between the residents, interested stakeholders, Indigenous Rightsholders and the project team. The West Caledon Storage Facility and Transmission Main study is being undertaken as a Schedule 'C' Municipal Class EA and will ensure public feedback is requested and accepted at the three prescribed PIC milestone events.

The first PIC event was held on November 9th, 2022 from 6 to 8 p.m. at the Margaret Dunn Valleywood Library and Community Room. The PIC No. 1 introduced the study's Schedule 'C' Class EA process and presented the problem and opportunity statement, existing study area conditions and short-listed wastewater servicing alternatives. As well, project team members were present to discuss study next steps, concerns, and additional opportunities for public involvement.
