What is new for 2025 (CWELCC)?

Funding to LHCC Agencies

1. LHCC agencies with head office in Peel



Peel is the overseeing SSM

2. LHCC agencies with head office outside of Peel



The SSM where the head office is located in the overseeing SSM

3. LHCC agencies with head office outside of Peel and opening new homes in Peel



Peel is the secondary SSM
*The SSM where the head office is located is the overseeing SSM

Next fee reduction

2024

As of Jan. 1, 2025

52.75%
fee
reduction

- **Fees are the lesser of:**
 - \$22/day OR
 - Frozen fee reduced by 52.75%
- **Minimum fee: \$12/day**

Examples of New Fee Reduction

Example	Approved daily base-fee (frozen)	After 52.75% reduction (Dec. 31, 2022)	Fee as of January 1, 2025
Example 1 - Before and After care only (JK/SK)	\$15/day	\$12/day (reduced to minimum)	\$12/day (stays the same)
Example 2 - Infant space	\$90/day	\$42.53/day (52.75% reduction applied)	\$22/day
Example 3 - Preschool space	\$40/day	\$18.90/day (52.75% reduction applied)	\$18.90/day (under cap, stays the same)
Example 4 - Toddler space	\$60/day	\$28.35/day (52.75% reduction applied)	\$22/day

If I'm not enrolled in CWELCC, do I qualify for any funding in 2025?

- ✓ No. "Non-participating licensees delivering child care to children aged 0-5 will no longer be eligible for routine funding"(page 3 of the memo).
- ✓ This means that your existing ELCC Agreement with Peel will end in 2024 you will not receive WEG, GOF/Base Funding, Historical, TOG (Special Purpose and Administration), EPS going forward.
- ✓ You may qualify for existing child care subsidies until children enrolled age out, become ineligible for subsidies or leave your program
- ✓ In the coming weeks, we will share communication to impacted agencies.

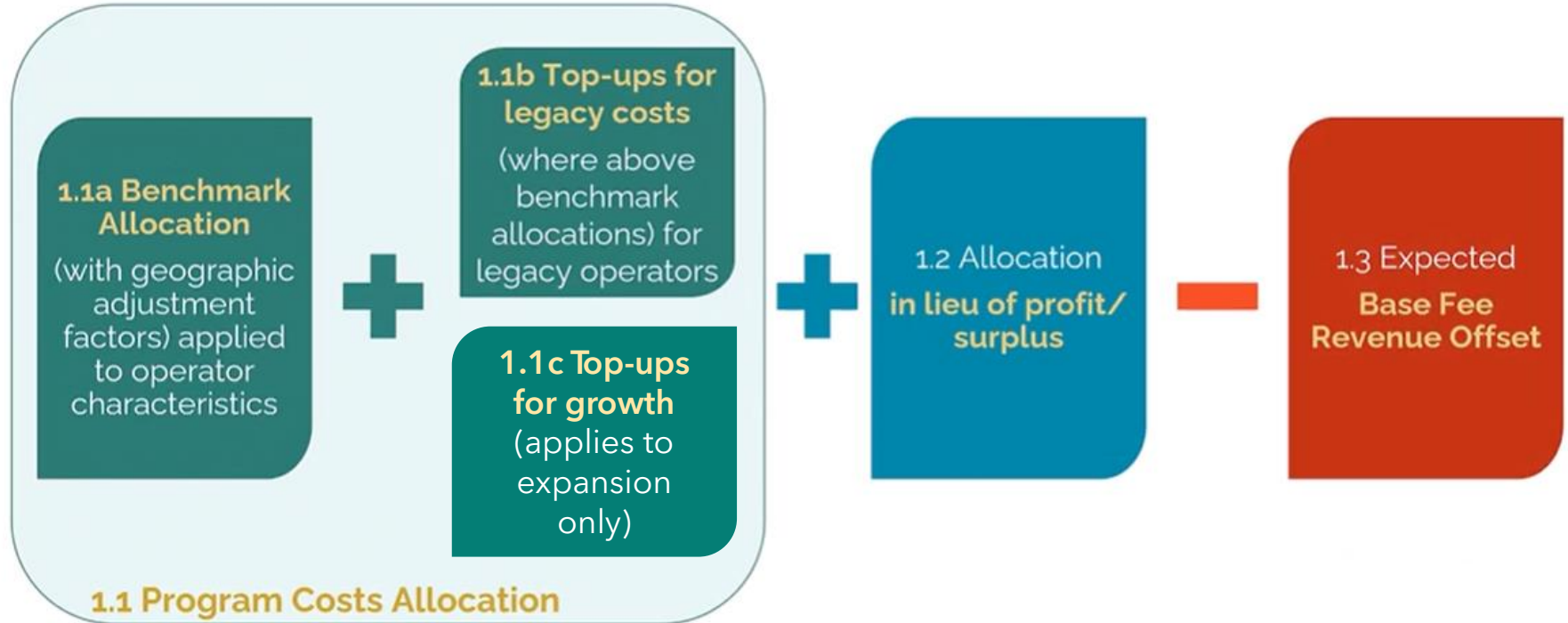
