

Food Premise Convictions

Peel Public Health inspects food premises for compliance with various legislation including the Health Protection and Promotion Act, 1990 and the Food Premises Regulation (Reg. 493/17). If a person fails to comply with the applicable legislation, a charge may be laid by a public health inspector.

Below is a list of businesses where a food safety related offence occurred and the owner or operator was charged and convicted. Convictions will be posted for two years from the date of conviction.
