

Consent to Disclose and Verify Information – Child Care Subsidy

Review, sign, and <u>send</u> this form to your Children's Services Worker as part of your Child Care Subsidy Application. We need your consent before you can receive Child Care Subsidy.

- 1. I understand that to receive Child Care Subsidy in Peel Region, I must consent to the collection, use and disclosure of information by, and the release of information to, an authorized representative of Peel Region's, Human Services Department for the purpose of determining or verifying my initial, ongoing, or past eligibility for Child Care Subsidy and administering my Child Care Subsidy.
- 2. Without in any way restricting the generality of the consent in section 1, I specifically consent to Peel Region's collection, use and disclosure of the following types of personal information pertaining to me/my child(ren) for the purpose of determining or verifying my initial, ongoing, or past eligibility for Child Care Subsidy and administering my Child Care Subsidy:
 - Income
 - Employment
 - Education and/or training
- Medical
- Address
- Status in Canada
- Family Composition including marital status, custody, and living arrangements.
- 3. Further, without in any way restricting the generality of the consent in section 1, I consent to Peel Region's collection, use and disclosure of my personal information to and from third parties including but not limited to Child Care Service Providers, Peel District School Board, Dufferin Peel Catholic District School Board, employers, education and training institutions, Ontario Works Delivery Agents, Housing Service Managers, referring agencies, other divisions within Peel Region, the Canada Revenue Agency, the Government of Canada, the Ministry of Community and Social Services, the Ministry of Education, the Government of Ontario Consolidated Municipal Service Managers, or any agency, ministry or department of any of the foregoing for the purpose of determining or verifying my initial, ongoing or past eligibility for Child Care Subsidy or administering my Child Care Subsidy.
- 4. I also understand Peel Region may, from time to time, contact me for feedback about my experience with the Child Care Subsidy program.
