1) Welcome and Opening Remarks

The Peel Agricultural Advisory Working Group (PAAWG) was called to order with quorum at 7:41 pm by Chair, Gary Mountain. Note: Prior to having quorum,

2) Declarations of Conflict of Interest

Gary Mountain declared a conflict of interest on Peel Rural Water Quality Program application 08-CVC-24 Education and on 09-CVC-24 Cover Crop. No other conflicts of interest were identified by members in attendance.

4) Review and Approval of Minutes of August 15, 2024 Meeting

5) Provincial Plans and Agriculture, Agriculture-Related and On-Farm Diversified Uses

Melanie Williams, Peel Region

At the May 16, 2024, PAAWG meeting, PAAWG requested information on the different Provincial Plans and the differences in the policies that permit agriculture, agriculture-related and on-farm diversified uses in the Prime Agricultural Area and Rural Lands. Information on why on-farm diversified uses were restricted in its size/footprint was also requested. Information was presented comparing the Greenbelt Plan, Oak Ridges Moraine Conservation Plan and the Niagara Escarpment Plan, showing where these activities were permitted or restricted in the Prime Agricultural Area and Rural Lands.

Questions/Discussion:

PAAWG questioned how on-farm diversified uses and agriculture-related uses are regulated if there is an unpermitted change of use of the property? Ben Roberts spoke to the role of municipal enforcement officers in ensuring zoning and permitting is followed.

6) Grown in Peel Reels

Melanie Williams, Peel Region

The Region has produced the first in a series of 1 minute 'reels' promoting Grown in Peel farm and farmer market listings, across the growing seasons. This reel has been publicly posted on social media platforms. The reel was shown to PAAWG. Members were made aware another reel was in the making for the upcoming holiday season and would showcase trees, food for dinners and decor. The reels and their related advertising were being posted on Facebook, Instagram and other Peel social media starting in September 2024.

Questions/Discussion:

PAAWG members asked about the number of followers to the reel on social media which staff indicated they would provide to the members. Melanie noted that staff were beginning the work as of December 2nd to gather locations for next year's Grown in Peel promotions. Chair Mountain complimented staff on the reel as good promotions. There was a question about whether a paper Grown in Peel guide could be done again with staff suggesting that at minimum a pdf version could be made available.

7) 20th Anniversary Peel Farm Tour

The 20th anniversary Peel Rural Water Quality Program (PRWQP) and ALUS Peel farm tour was held Wednesday, October 2, 2024, at Spirit Tree Estate Cidery, Caledon, and emceed by Chair Mountain. Program staff provided an overview of the outcomes of the day. Overall, it was a well attended day with seventy-eight people including twenty farmers on the tour. Keynote speaker the Honourable Senator Rob Black, Ontario, spoke about the Senate Committee's report entitled *Critical Ground: Why Soil is Essential to Canada's Economic, Environmental, Human, and Social Health.* He also presented a special certificate from the Senate to PAAWG to celebrate the 20th anniversary and success of the PRWQP.

No questions. Chair Mountain provided compliments to the organizers and hosts of the tour.

8) ALUS Peel Pilot Evaluation

Holly Shipclark, Credit Valley Conservation Mary Anne Young, Toronto and Region Conservation

The 3-year pilot of the ALUS Peel Pilot program will end February 2025. An evaluation of the pilot program is required for the program partners to determine if

the program will be adopted. Program staff completed an evaluation of the pilot's achievement of milestones and feedback from ALUS Peel Pilot participants. Results and recommendations were presented for PAAWG's feedback and endorsement.

Key findings included:

- 1. Peel farmers are interested in participating in a permanent ALUS Peel program.
- 2. Annual payments are valuable to farmers.
- 3. Annual payments may encourage greater implementation of Peel Rural Water Quality (PRWQP) projects that provide ecosystem services, but further evaluation is required.
- 4. Association with ALUS National elevates the profiles of the Peel agricultural community.
- 5. The PRWQP benefits from some of the tools and resources available through ALUS National.
- 6. The delivery of the ALUS Peel program is cost effective to the program partners.

The Memorandum of Understanding for the ALUS Peel Pilot will conclude on February 7, 2025. The preliminary pilot evaluation demonstrates positive outcomes that recommends that ALUS Peel becomes a permanent program of the partnership of ALUS National, Peel Region, CVC and TRCA.

9) Peel Rural Water Quality Program & ALUS Peel Pilot

a) Financial Report

The 2024 Peel Rural Water Quality (PRWQP) program year has a budget of \$70,000.00. With additional contributions through other funding partnerships for specific projects, this budget has been augmented to \$25,253.26. Pending the approval of the November 21, 2024, projects, as presented, the total remaining balance is \$33,306.45.

The 2024 ALUS Peel Pilot contribution for annual payments for new projects is \$7,500.00 of which \$6,432.50 has been previous allocated. Requested new annual payment grant allocation (subject to PAAWG approval) in the amount of \$4,635.00, and of which \$3,297.50 is subject to additional funding from ALUS National.

b) Project Applications

Duncan Ivany, Credit Valley Conservation

I. 08-CVC-24 Education (PRWQP)

Application 08 -CVC-24 proposes \$983.00 for a Peel Soil and Crop Improvement Association 10 acre (4 ha) demonstration plot of cover crops. This project helps pilot the establishment and overwintering of new varieties of cover crops, to educate the community on the benefits of different cover crops contribution to the reduction of erosion.

Questions/Discussion:

As quorum was not met, the project was discussed but could not be voted on. Karen Hutchinson noted many on PAAWG have seen the proposed project and PAAWG members present were generally supportive.

II. 09-CVC-24 Cover Crop (PRWQP)

The application 09-CVC-24 proposes \$2,000.00 for 50 acres (20 ha) of cover crops. This project helps the establishment and overwintering of cover crops, contributing to the reduction of erosion, enhancement of area conditions, and reduced risks related to a highly vulnerable aquifer.

Questions/Discussion:

As quorum was not met, the project was discussed but could not be voted on. In general, PAAWG members present were supportive of the project.

Gary Mountain returned to the room and the role as the Chair at 8:45 pm. Quorum returned.

III. 03-TRCA-24 Natural Area Enhancement and Creation (PRWQP & ALUS Peel Pilot)

The application 03-TRCA-24 proposes \$5,542.08 in Peel Rural Water Quality Program grants and \$1,800 in ALUS Peel Pilot grants for the restoration of marginal farmland.

The application 04-TRCA-24 proposes \$7,849.61 in Peel Rural Water Quality Program grants and \$4,635.00 in ALUS Peel Pilot grants for the restoration of marginal farmland.

That application 04-TRCA-24 be approved and that Peel Rural Water Quality Program funding be provided in the amount of \$7,849.61 under the category "Tree Planting", with the condition of submission of an Environmental Farm Plan.
