- Cultural Heritage Study (Study Area and Preferred Alternative)
- Desktop Geotechnical Study (Short List of Alternatives and Preferred Alternative)

Once the draft reports are available, the Region can share them with you for review and feedback. The Region of Peel is open to engaging Indigenous Rights holders on additional studies that may be required.

Through the MCEA process, we will be completing an evaluation of the offline storage location alternatives. The evaluation considers five key criteria including technical, natural environment, social-cultural heritage, jurisdictional and financial to select the best overall strategies, while minimizing impacts to Indigenous Rights Holders, the community, and the environment. This includes impacts to watercourses, sensitive natural features, drinking water, wildlife habitat, endangered species, archaeological resources, and climate change. The following principles will be used to minimize impacts to the environment, where possible:

- Avoid natural areas of significance and impacts to species of cultural importance to Indigenous Rights Holders
- Avoid areas where archaeological resources have been identified
- Select location in close proximity to WWPS





I do have a question regarding the statement “territory of the Mississaugas of the Credit First Nation who are direct descendants of the Mississaugas of the Credit”

Can you provide the evidence that directly related the MCFN archaeologically speaking there is no evidence through artifacts or history supporting this claim. I will mention that there is a direct evidential relationship to the Senecas and Hurons in many of your surrounding areas. We do not have the capacity to educate like the MCFN does in these areas so their narrative has been told from only their site leaving our many critical historical data.

I though it was important to mention this as First Nations have shared the land for many, many years through nomadic method of hunting and gathering. It’s a colonial thought to divide land and give possession (ownership)

I would further explain this as I know that this narrative has been travelling around. Just always keep in thought that ownership is a colonial thought. We have a long way to go sharing the history in a correct inclusive manner.

I though it was important to mention this as First Nations have shared the land for many, many years through nomadic method of hunting and gathering. It's a colonial thought to divide land and give possession (ownership)

I would further explain this as I know that this narrative has been travelling around. Just always keep in thought that ownership is a colonial thought. We have a long way to go sharing the history in a correct inclusive manner.

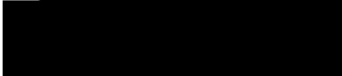
