## 5) Humber River Watershed Plan Update

The Toronto and Region Conservation Authority (TRCA) is updating the Humber River Watershed Plan. TRCA has completed the Watershed Characterization Report and is developing the framework to develop program, policies, targets, priority actions and key indicators for TRCA to undertake its role in the protection and enhancement of the water resource system, natural heritage system, water quality, and natural hazards. TRCA presented the Management Framework process to PAAWG.

# 6) Credit Valley Conservation Discussion Paper for the Golden Horseshoe Food & Farming Alliance

Holly Shipclark, Credit Valley Conservation

Credit Valley Conservation (CVC) is preparing a proposal for the Golden Horseshoe Food and Farming Alliance (GHFFA), for a best practices manual for the on-farm management of stormwater from farm buildings/structures, including buildings that support on-farm diversified uses. PAAWG was requested to provide guidance on what should be scoped into the document that would be beneficial to farmers. The proposal will be presented to the GHFFA Board at an upcoming meeting. From there the timeline to develop the project will be determined.

#### **Questions/Discussion:**

PAAWG identified that there was a need for this type of information. They indicated it should include ways farmers could work with municipal partners to learn to manage stormwater. PAAWG noted by showcasing, to both farmers and municipalities, the practices/tools farmers can use as green infrastructure through demonstration sites would be helpful in increasing adoption of beneficial practices. PAAWG encouraged continued grants to support demonstrations and early adopters.

### 7) PAAWG Terms of Reference

Melanie Williams, Peel Region

The PAAWG Terms of Reference (TofR) was approved in 1997 and has undergone revisions since then to align with PAAWG's and the Region's changing roles and responsibilities. The proposed revisions are being undertaken to:

- align the TofR with changes to Peel's Regional roles and responsibilities
- change ALUS Peel from a pilot to permanent role of PAAWG
- undertake housekeeping amendments to recognize common practices that are in place

None of the proposed revisions add new roles or responsibilities to PAAWG. Any revisions to the TofR are to be endorsed by PAAWG and approved by Regional Council through a staff recommendation report to Council.

#### **Questions/Discussion:**

PAAWG acknowledged that local municipal staff attend PAAWG meetings depending on agenda items, requests to delegate, etc. PAAWG requested if there is an opportunity to strengthen the tie to the local municipal planning division(s) or appoint a representative(s) to PAAWG. Peel Region staff will take this feedback for further consideration. PAAWG requested that that the role of PAAWG to 'protect agricultural and rural lands as a natural resource of major

importance to the economic viability of the Region', remain versus the proposed revision to 'support', though recognizing the Peel Regional Official Plan is now implemented through the local municipalities.

## b) Financial Report

The 2025 Peel Rural Water Quality (PRWQP) program year has a budget of \$73,000.00. Additional cost-share funds of \$11,751 through TRCA, from other funding partners for the three projects within TRCA's jurisdiction, is also available pending the approval of the May 15, 2025, projects. As presented, pending approval, the total remaining PRWQP budget balance for 2025 is \$68,000.

The 2025 ALUS Peel contributions for new annual payments is still being confirmed by ALUS National. The requested new annual payment grant allocation is \$0. There is still \$4,635 for projects approved by PAAWG in 2024 and 2025, which are still subject to funding confirmation from ALUS National.

#### c) ALUS Peel Update

CVC noted there were no ALUS Peel projects at this meeting. ALUS National will be confirming its 2025 funding for the annual payments soon. More information should be available at the August PAAWG meeting.

## d) Proposed 2025 PRWQP and ALUS Peel Twilight Farm Tour

TRCA and CVC are proposing to host a twilight tour instead of a farm tour this year. CVC provided a brief background on what the twilight farm tour could include and requested ideas be provided to the CA program staff, soon as possible. Potential dates were reviewed.

## e) Update on 08-CVC-24 Peel Soil and Crop Improvement Association Cover Crop Education Program

Holly Shipclark, Credit Valley Conservation Gary Mountain, Peel Soil and Crop Improvement Association

In 2024, PAAWG approved a PRWQP Education Grant for the Peel Soil and Crop Improvement Association (PSCIA), to trail different cover crops as a demonstration project for the community. As a condition of funding, PAAWG requested that the PSCIA provide an update to PAAWG on the outcomes of the trail, to help inform the PRWQP Cover Crop project category. Gary Mountain presented on behalf of the PSCIA, providing information and photos of the eight different cover crops. The trial was used as a demonstration site for the 2024 Peel Farm Tour.

## f) Project Applications

Karen Buckle Credit Valley Conservation

I. 02-CVC-25 Cover Crop

Application 02-CVC-25 proposes \$2,000.00 for 50 acres (20 ha) of cover crops. This project helps the establishment and overwintering of cover crops, contributing to the reduction of erosion and enhancement of area conditions.
