- Amplifying the voices of equity-deserving residents and improving community engagement practices
- Co-lead Peel Newcomer Strategy Group with over 200 local service providers

Achievements

2024 OMSSA Local Municipal Champion Award

Over 12,000 Peel residents accessed supports through the Wellness Response Assistance Program and **over 900** residents benefitted from the Digital Literacy Program, enhancing access to vital resources while addressing immediate needs.

Peel Youth and Poverty Research Project

Poverty Reduction Initiatives Staff successfully **launched the Youth Advisory Table**, a group of more than 15 youth from diverse backgrounds to inform the Youth and Poverty Project. To date, 28 youth-focused service providers have been interviewed.

2025 CAO Award of Excellence

Community Investment staff assisted in convening immigration and settlement service providers to deliver culturally appropriate services to support new asylum claimants during their settlement journey in Canada.

Peel's First Human Trafficking Youth In-Transition Worker

Peel's Anti-Human Sex Trafficking Program secured annualized Provincial funding to support entrenched youth to connect to existing supports and resources in Peel as they transition out of care.



Increase staffing to Community Investment Program




