

Smoking and Vaping Related By-law Convictions

Peel Public Health inspects businesses for compliance with the Peel Waterpipe Smoking By-Law and the Peel Outdoor No Smoking or Vaping By-law.

If a person fails to comply with the legislation a charge may be laid by a public health inspector.

Below is a list of premises where an offence occurred under the by-laws and the owner or operator was charged and convicted. Convictions will be posted for two years from the conviction date. This list was last updated on **December 3, 2025**
