Parking Regulations

The following regulations apply to the use of the parking facilities.

1. Parking charges are for the use of a parking space only.
2. The Landlord and its agent and their employees are not responsible or liable for any injury, theft, loss or damage to you or your vehicle or its contents.
3. The parking of unlicensed, non-roadworthy vehicles, the storage of vehicles, and the repair or maintenance of vehicles is prohibited.
4. Further, the parking of vehicles that (in the opinion of the Landlord or its agent) pose any kind of hazard or have hazardous contents is also prohibited.
5. Tenants are subject to the terms and conditions displayed on all signs on Peel Living property.
6. The Landlord reserves the right at any time to refuse or change assigned parking.
7. Tenant may terminate the monthly parking agreement upon one month's WRITTEN notice (i.e. notice given at any time during a month will take effect on the last day of the following month).
8. Landlord or its agent may terminate the monthly parking privileges upon one month's notice. Breach of the parking regulations described herein and/or municipal bylaws or property regulations may result in suspension of parking privileges and/or ticketing and/or towing of the vehicle at the owner's expense.
9. The tenants cannot assign or transfer parking privileges to another vehicle without prior written consent.
10. The parking regulations are subject to change without prior notice.
