

Smoke-Free Ontario Act (and Electronic Cigarette Act) Convictions

Peel Public Health inspects businesses for compliance with the Smoke-Free Ontario Act, 2017.

If a person fails to comply with the legislation, a charge may be laid by a public health inspector.

Below is a list of premises where an offence occurred under the legislation and the owner or operator was charged and convicted. Convictions will be posted for five years from the conviction date. This list was last updated on August 5, 2026.
