# **Imagine a Day Without Water Poster Contest**

## **CONSENT FORM**

## **RULES AND CONDITIONS**

## The Imagine A Day Without Water Poster Contest (the "CONTEST"):

The Contest is operated by The Regional Municipality of Peel ("Region of Peel") through Peel Public Works, and will award one prize per grade (K-12) from among eligible entries received by the Region of Peel. The contest period commences **October 1, 2020 and shall end on October 31, 2020** (the "Contest Period"). The Contest is subject to the following rules ("Rules"):

## HOW TO ENTER:

During the Contest Period:

- Create a poster that adheres to the following guidelines:
  - Posters must focus on the theme 'Imagine a Day Without Water' and illustrate the importance of water and wastewater treatment in our lives.
  - Posters must be designed according to the following specifications:
    - All posters will be in colour and sized 8.5" x 11".
    - Posters may be in landscape or portrait orientation.
    - Posters may be hand drawn or computer illustrated.
    - Any computer images or photos included in the poster must be properly attributed and be the original work of the artist OR have a Creative Commons license (see creativecommons.org).
- Read and agree to the Contest Rules and Conditions which includes consent for the Region of Peel to reproduce, print, modify and use in both print and digital media any and all submitted posters.
- Complete the Consent Form
- Submit an electronic copy or high-quality scan of the poster, and the Consent Form to the Region of Peel at <u>WaterTrain@peelregion.ca</u>;
- Please keep your original artwork. If chosen as a winner, the original artwork may be requested to ensure a high-quality image is used for the poster.
- **One entry per applicant**. All entries become the property of the Region of Peel.

## ELIGIBILITY:

To be eligible to win one of thirteen prizes, the participant must:

- Be a resident of Peel Region and be enrolled in a School in Peel, or be homeschooled within Peel;
- Be eighteen (18) years of age or older at the time of entering the contest OR have their parent or legal guardian consent to participate by signing the Consent Form.

Employees of the Region of Peel, as well as their immediate family members and/or persons living at the same address are not eligible to participate in this Contest and/or win one of the prizes.

## PRIZES:

Prizes will be awarded to one winner from each grade (K-12):

- Each winner will receive one poster-sized copy of their entry to keep;
- Certificates of recognition will be provided to winning entries;
- Certificates of participation will be provided to all entries;
- The winning posters will be highlighted in Social Media

## CONDITIONS OF WINNING:

The winning posters will be selected by a panel of judges comprised of staff from the Region of Peel.

The winning entries are subject to fulfillment of all the conditions described in the Rules. To win one of the prizes, a potential Contest winner must:

- Meet all eligibility requirements including the execution and return of the Consent form
- Provide name and email number to contact if chosen as the Contest winner;

If a potential Contest winner:

- (a) cannot be contacted by email by the end of ten (10) business days following selection; or
- (b) has not, or does not comply with the Contest Rules; then another potential Contest winner will be chosen from the eligible entries received during the Contest Period.

All prizes will be mailed to the contest winners' home address.

## **GENERAL CONDITIONS:**

By entering this Contest, participants agree to be bound by these Rules. Participants further agree to be bound by the interpretation and decisions of the jury panel which will be final and binding in all respects.

- 1. The Region of Peel reserves the right in its sole discretion to disqualify any participant it finds:
  - a. To be tampering with the Contest entry process and/or the operation of the Contest; or
  - b. To be acting in violation of the Rules;
- 2. The Region of Peel will not be responsible for incomplete, lost, late, or misdirected entries/submissions. It is the participant's sole responsibility to ensure that its entry/submission complies with these Rules and is received by the Region of Peel on or prior to the end of the Contest Period;
- 3. If for any reason the Contest is not capable of running as planned, or if the administration, security, fairness, integrity or proper conduct of the Contest is corrupted or adversely affected, including by reason of infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the Region of Peel's control, the Region of Peel reserves the right to cancel, terminate, modify or withdraw the Contest without prior notice and without liability to the Region of Peel. If the Contest is terminated, the Region of Peel will give email notice to the participants who have submitted a poster;
- 4. The Contest is governed by the laws of Canada and any applicable provincial and municipal laws and regulations;
- 5. Participants release and hold harmless the Region of Peel and their respective affiliates, subsidiaries, directors, officers, elected officials, Chair, volunteers, agents, employees, and all those for whom it is legally responsible associated with the development and execution of this Contest from any and all liability with respect to or in any way arising from this Contest and the awarding, use or misuse of the Grand Prize, including liability for bodily or personal injury and loss or damage to any person or property.
- 6. The Contest will use reasonable means to protect the security and confidentiality of information sent and received by email. However, the Contest cannot guarantee the security and confidentiality of email communication. I acknowledge these risks and consent to communication by email for purposes related to the Contest.

Contest winners must accept the prizes as awarded; prizes are not redeemable for cash.
